#### AFSEC's First Technical Workshop from 10 – 11 August 2010

From 10<sup>th</sup> to 11<sup>th</sup> August 2010, AFSEC held its first Technical Workshop in Johannesburg, South Africa. During his opening remarks and welcome Claude Koutoua expressed his delight over having to preside over the opening ceremony of AFSEC's first technical workshop. He added that the presence of all the delegates reflected a definite advantage to being united in seeking solutions to common problems.

He further explained that the workshop was timely as it reviewed the following points:

- Progress with the harmonization of electrotechnical standards in African regional economic communities.
- The need for standardization to achieve integration of interconnected power pools in Africa
- The needs and priorities of electrotechnical standards to be established in Africa
- The proposal for the structure of the initial technical review committee to recommend to the Management Committee AFSEC;
- Nominations for membership on committees of technical studies;
- The proposed appointment of chairmen and secretaries of committees of technical studies

#### **Message from IEC General Secretary to AFSEC**

IEC has grown considerably since the inaugural AFSEC assembly in 2008 – from 146 countries back then to 162 countries today. And that growth in membership and affiliates has been due, in large part, to the African nations' commitment to the constitution of national electrotechnical committees that are truly representative of their key stakeholders including electricity generators, the distribution industries, the standards body and/or the regulatory authorities.

Not only has Africa's commitment to the IEC increased since that inaugural meeting in Ghana. The IEC's commitment to Africa and to AFSEC has increased. With the signing of the IECAFSEC Cooperation Agreement in 2009, the two organizations have made formal commitments to each other. On the specific issue of IT tools, I am happy to note AFSEC will be trialling the popular IEC Collaboration Tools platform with a view to using this among the AFSEC members.
